Introduction

Food Policy Groups' Responses and Adaptations to COVID-19

The COVID-19 pandemic has upended our food system, making problems worse for communities that already struggled to meet basic needs yet at the same time showing the resiliency of local food systems. Food Policy Groups (FPGs)* are stepping in to play a key role in their communities' response to the pandemic.

The [Food Communities Network \(FCN\)](#), in collaboration with the [Johns Hopkins Center for a Livable Future](#), is conducting a survey to learn about how Food Policy Groups (FPGs) are responding to COVID-19, what challenges you are facing, and what successes you have achieved. We are reaching out to see if you will share with us about your FPG's response to the pandemic by filling out this survey.

***Uncertain if your group is a food policy group (FPG)?**

We consider an FPG to be a formal or informal group or network of residents, non-profit organizations, businesses, government staff, etc. working together to address issues across the food system, primarily through policy or programs, at the local (city/municipality/county/region), provincial/territorial, or Indigenous community level. No matter if your group goes by another name, such as a food policy council, food systems alliance, or food justice initiative, **if this definition describes your group, then this survey is for you!**

Questions and Timeline:

We recognize that you and other members of your FPG are doing critical work at this time and are extremely busy balancing work and family obligations. We greatly appreciate your effort to take this survey. The survey takes about 30 minutes to complete. You may save your responses and return anytime using the same device by **September 30, 2020**. How will the info be used?

By filling out this survey, you are helping to document the value and impact of FPGs in addressing COVID-19-related food systems needs in communities across the country. You are also helping to reduce requests for interviews or surveys from other researchers. We will share raw data, from which we will have removed any non-public contact

information, with vetted partners/researchers. A summary report of findings from across all FPGs surveyed will be shared with you upon completion of the project.

Please note that basic contact information from these survey questions will be used to update a public Food Communities Network directory for Food Policy Groups. This will also be linked to the John Hopkins' website (USA) and other international networks.

What happens from here

We will ask you to fill out this survey one more time over the next nine months to see how your FPG's COVID responses have evolved over time. The first survey is the longest because it includes questions collecting basic information on your FPG. If you have previously filled out an annual survey from the Johns Hopkins Center for a Livable Future about your FPG, most of these questions will look familiar to you.

FPGs that fill out the two surveys will be entered into a draw.

Four (4) FPGs will be randomly selected to receive \$500 to support their activities.


